The Berks County Tax Collection Committee sent out an email explaining the merger between the TCC and Berks EIT Bureau, to take effect for 2015. The also sent a proposed resolution for appointment of a Primary Delegate and an Alternate Delegate. The idea is that all municipalities within a school district will get together and vote in one Primary Delegate and an Alternate.
